Who We Are

Endeavor Evolution Enterprises LLC ("Endeavor Evolution," "we," "us," or "our") operates a connected set of service offerings—including Elite Funding, Elite Credit Care, and Elite Filings— to help clients become "funding-ready," improve credit, and form or amend business entities. This Privacy Policy explains how we collect, use, disclose, and protect personal information when you interact with our Site, contact us, schedule time with us, or use our services.

Scope

This Policy covers personal information we collect on the Site (including contact forms), through third-party scheduling tools you access from the Site (e.g., Motion at app.usemotion.com), and via email, phone, meetings, and service delivery. This Policy does not cover third-party websites, platforms, or services we don't control (including Motion or any payment processor you choose). Those services have their own privacy policies.

Information We Collect

A. Information You Provide

- Identifiers & Contact Details: name, email, phone, address (e.g., entered in our contact form orduring scheduling/consults).
- Professional/Business Data: business name, role/title, EIN, state of formation, filing needs, funding goals.

- Credit/Funding Context: if you choose to provide it for assessments (e.g., credit profilesummaries, documents, or stated income).
- Government/Registration Details (for filings you request): state selections, member/manager info,amendment details.
- User Content: messages, attachments, or notes you provide through forms or email.
- Payment Information: if fees are collected online, payments are processed by a thirdpartyprocessor; we typically receive only confirmation data (not your full card/bank details).

B. Information Collected Automatically (Cookies & Similar)

- Device/Usage Data: IP address, browser type, pages viewed, links clicked, and timestamps.
- Cookies/Tracking: small files stored on your device to enable core functionality and (if enabled)analytics or advertising measurement.

C. Information From Third Parties

- Scheduling/Calendar Platforms (e.g., Motion): appointment details you submit through theirportals (name, email, chosen time, notes).
- Payment Processors: transaction confirmations, status, and limited metadata.
- Referral Partners & Integrations: if a banker/partner refers you, we may receive limited profiledetails to coordinate services.

D. Sensitive Information

In limited cases—only when you choose to provide it for credit repair, funding readiness, or filings—we may process data that could be considered sensitive (e.g., government IDs in formation documents or financial particulars for underwriting preparation). We request only what is reasonably necessary for the services you ask us to perform.

How We Use Information

We use personal information to:

• Provide, operate, and improve the Site and services (funding advisory, credit care, businessfilings).

- Respond to inquiries, schedule consultations, and deliver client support.
- Assess eligibility or fit for funding-related strategies you request (we are not a bank or lender).
- Prepare entity filings or amendments at your direction and coordinate with state agencies orregistered agents.
- Send service messages (confirmations, updates, legal notices) and—with your consent—marketing communications.
- Maintain security, prevent fraud, debug, and comply with legal obligations.
- Create aggregated, de-identified insights to improve our offerings.

No automated decisions with legal or similarly significant effects are made about you without human involvement.

No mobile or messaging consent information will be shared with third parties/affiliates for marketing/promotional purposes. All the above categories exclude text messaging originator optin data and consent; this information will not be shared with any third parties.

Our Legal Bases (EEA/UK only)

Where the GDPR/UK GDPR applies, we process data on the following bases:

- Contract (Art. 6(1)(b)): to deliver services you request.
- Legitimate Interests (Art. 6(1)(f)): site operations, security, improvements, and limited directmarketing to existing users.
- Consent (Art. 6(1)(a)): for optional features (e.g., certain cookies/marketing).
- Legal Obligation (Art. 6(1)(c)): recordkeeping, tax, compliance.

How We Share Information

We may share information with:

- Service Providers/Processors: hosting, scheduling (e.g., Motion), CRM/helpdesk tools, email/SMS platforms, payment processors, IT/security, analytics (if enabled), and registered agent/filing channels acting on our behalf and under contract.
- Professional Partners: at your request (e.g., introductions to lenders, bankers, attorneys, accountants).

- Government/Regulatory Bodies: when you request filings or when required by law, subpoena, orcourt order.
- Business Transfers: in connection with a merger, acquisition, or asset sale, subject toconfidentiality.
- With Your Consent: where you direct us to share with others.

We do not sell personal information for money. If we ever "share" data for cross-context behavioral advertising under California law, we will provide a "Do Not Sell or Share My Personal Information" link and update this Policy.

Cookies & Tracking Choices

- Essential Cookies: necessary for the Site to function (cannot be turned off in our systems).
- Analytics Cookies (optional): help measure traffic and usage to improve the Site.
- Advertising Cookies (optional): if enabled, these support ads personalization and measurement.

Your Options:

- Browser settings to block or delete cookies.
- Platform-specific opt-outs (e.g., Google Analytics opt-out).
- If enabled in the future, a cookie banner/manager on our Site to manage preferences.

Do Not Track: We do not respond to DNT signals at this time.

Retention

We retain personal information only as long as necessary for the purposes described above—considering the amount, nature, and sensitivity of the data; the potential risk from unauthorized use or disclosure; and applicable legal/operational requirements (e.g., tax and accounting rules). When no longer needed, we take reasonable steps to delete, de-identify, or anonymize the data.

Security

We implement reasonable technical and organizational safeguards designed to protect personal information (e.g., access controls, encryption in transit for the Site, least-privilege practices for staff/contractors). No method of transmission or storage is 100% secure; please use caution when sending sensitive information and contact us if you have any security concerns.

Children's Privacy

Our Site and services are not intended for children under 13 (or under 16 in the EEA/UK). We do not knowingly collect data from children. If you believe a child has provided personal information, contact us and we will take appropriate steps to delete it.

Communications Preferences
